TERMS OF PARTICIPATION

2. To provide a safe school environment, all vendor employees working the day of the event must be listed on page three of this document to comply with the San Marcos Unified School District Volunteer Acknowledgement and Notice or Amended Education Code Section 35021 form.
3. San Marcos Music Boosters and/or San Marcos Unified School District may dismiss a vendor from an event at any time and for any reason.
4. The vendor will submit payment to San Marcos Music Boosters, at time of registration.

Agreement includes reserved space in our vendor area which will be assigned on a first come first served basis at the discretion of the organizers. Show space does not include any walls or fixtures so please bring your own tables, chairs, and means to display products. Vendor booths will be located under the solar structure but vendors can erect 10x10 pop ups, as desired, for additional shade and branding. Electricity and wifi will not be available for vendor use during the event. Vendors are responsible for load-in and load-out and agree to remove all products, fixtures, signage, and trash from their booth at the end of the event. Signage, price lists, sale and return policies, credit card reader, cash and change, and promotional flyers are all encouraged to enhance the shopping experience for show attendees and are the responsibility of the vendor to provide. Because the SMHS band will be performing during the event, music in vendor booths is not allowed. Open flames, cooking, and preparing food ingredients by a vendor in their booth is not permitted. Sale of food prepared offsite is allowed and individual packaged servings are encouraged as well as appropriate disclosure of ingredient and allergy information. Vehicle load in starts at 7 am and gates close at 9 am. We encourage vendors to arrive by 8 am to set up their booth so they are ready to sell when the car show starts at 9 am. Please check-in at registration when you arrive at the event. Vendor vehicles must be parked in the staff parking lot at the front of the school after unloading and will not be allowed to enter the vendor area again until all show vehicles have exited the event. Since vehicle exhibitors will be arriving early, there may be potential customers present anytime after 7:30am. Vendors are free to begin taking down their booth space at 1:00pm. For any questions or issues during the event, please contact the registration desk located by the school entrance.
